### ADDITIONS AND CORRECTIONS TO LINEAGES IN THE TURRENTINE FAMILY

I will be accepting additions and corrections for <u>The Turrentine Family</u>, 5<sup>th</sup> edition through the end of 2019. After that, Susan Turrentine and I will be concentrating on adding the new information and proof reading. Because the 5<sup>th</sup> edition will be in electronic format, there are some concerns about data scraping and identity theft. I have made a decision to only show the year of birth for living individuals and not the day, month, nor place of birth. If you want your full birth date in the publication, or if you wish to be omitted from the 5<sup>th</sup> edition entirely, please contact me by the end of the year. The full dates of birth will be retained in a Turrentine Family genealogy file that is to remain unpublished. Contact me at <u>jehodges@email.com</u>.

#### **DNA Update**

We would like to get someone onto the PBS show Finding Your Roots. The requirement is that the person be "famous", so it generates viewers and hence can obtain financing. I was wondering if a celebrity descendant of the musician Stanley Turrentine might be willing to contact Henry Louis Gates, Jr. about being on the show?

So far we have identified over 350 Turrentine cousins who have tested at Ancestry.com. There are also testers at 23 and Me, Living DNA, My Heritage, and Family Tree DNA (FTDNA). FTDNA is where the Turrentine DNA group has been established. DNA data from other companies can be uploaded to FTDNA. Cousins may join the Turrentine group at FDNA, but we particularly want males who have taken the Y-DNA test to join that group and post a tree that shows how they descend from Samuel, Alexander, or some other Turrentine who has not yet been attached to the tree.

At AncestryDNA, we have found atDNA (cousin) matches between descendants of the siblings of Samuel Turrentine #10 and some of the slaves belonging to Samuel. Samuel's will does state that any of the named persons are as his children. The matches, so far, are to descendants of Mary Turrentine, Nathan Turrentine McMannen and William Turrentine McMannen, who are listed as a group a slaves in the will. These families also used McManning, McMannan, McMannon, and Mack as a surname. The matches indicate, but do not prove, that Samuel was their father or grandfather. The complication is other common ancestor surnames from Orange County, North Carolina in the trees of the matches. This complication also occurs in the matches between T-cousins with documented relationships to Samuel and Alexander, as the actual matching atDNA segments could have come from the Wilson, Stewart, Bryant, Harris or tens of other families that we have intermarried with over the generations, rather than the in common Turrentine ancestor. This is particularly true when siblings married siblings and cousins married each other. Comparison of the actual matching atDNA segments needs to be completed. This is a long and tedious process.

FTDNA gives the matching segment locations, but Ancestry does not. The comparison using Ancestry tested atDNA can be accomplished at by downloading the raw data, then uploading to FTDNA and/or GEDmatch.com. If you upload to FTDNA, please join the Turrentine surname group. Sometimes the upload to FTDNA costs \$20, other times it is on special for "free", with a \$20 fee if you want to contact your matches. Upload to GEDmatch is always free, and you only pay if you personally want to use the advanced matching tools. I usually buy a \$10 monthly membership once or twice a year. I can download segment data by chromosome, construct matching matrixes and help support the free portion of the matching service. If you have a test at any of the companies, please send me know your sample number/name, so I can look for your potential Turrentine segment match locations.

Gwen Olson has been diligently working to document Turrentine slaves in wills and sales documents, census, death records, and newspapers in Orange and Durham County, North Carolina and has attempted to follow their descendants as they spread our across America.

Susan Turrentine has been working on expanding the trees of the AncestryDNA Turrentine cousin matches to add their ancestors listed in the 5<sup>th</sup> edition of "The Turrentine Family". Some individuals have not entered their trees and we have been unable to correctly identify their lines. If you need help taking your tree back on Ancestry.com, please contact me (Joyce Hodges, jehodges@email.com) and I will assist you. We plan to designate lineages where a descendant has tested by using colored text. For example: ancestors name in blue text for AncestryDNA. Living individuals' names will not be

highlighted, unless you specifically ask for a designation. Please email me, Joyce Hodges, (<u>jehodges@email.com</u>) if you have tested and want that indicated by highlighting your name in the 5<sup>th</sup> edition. Also tell me which company(s) you tested with.

Family Tree DNA is now requiring law enforcement to register any accounts that are being used to solve cases and giving private parties the choice to opt out of being matched with those uploaded samples. If you wish to opt out, go to "Privacy & Sharing" and look for "Law Enforcement Matching". If you have opted into matching and indicated a non-European address the default is opt in. If your address or email indicate a EU origin, the default is opt out. I personally would be glad to help lead the police to a suspect. The match cannot be used in a court of law to convict someone. It can only be used as clues to narrow law enforcement search. I don't know if it has been used as evidence to obtain a search warrant. If it has, it is sure to be challenged in court. Some people who have been admitted to the United States or Canada under asylum provisions may wish to opt out, to avoid the chance of misuse by a foreign government. However, I would imagine they have already opted out and only change the setting for a current session to review matches and then turn it back off before they log out.

GEDmatch also has an opt in feature if you wish to assist law enforcement.



Daniel F. Morton was born 7 February 1932, in Gore, Oklahoma to Henry F. Morton and Minnie Ethel




